Uplifting Supports In 2018, Corwyn's Cause provided uplifting practical supports to medically fragile children and their families. Uplifting supports included the following: weekly lawn care, monthly housecleaning, food at home and while the medically fragile children were in the hospital, snow removal, Christmas light installation, and welcome boxes. The number of medically fragile children supported by Corwyn's Cause increased by over 250% from the beginning to the end of 2019.

Family events enable a time to share experiences, have fun, and build community. Knowing that you are not alone on this journey makes all the difference.
