In caring for medically fragile children, families tend to become isolated in the home. Many families do not know any other families with medically fragile children. Family events enable a time to share experiences, have fun, and build community. Knowing that you are not alone on this journey makes all the difference.

Education and awareness: Through our research, we have identified over 3,000 medically fragile children in the radius of our local children's hospital. Employees, board members, volunteers and community advocates provided education and awareness to the need of pediatric palliative care. Our local children's hospital started their first pediatric palliative care program during 2019 and Rays for Rare sits on the committee to help guide, educate, and share awareness of the children we serve. We provided community education and awareness during the year through a series of storytelling videos sharing our families' journeys, speaking engagements, events and media coverage.
