Management of these resources includes selection of investment advisors,establishing investment targets and allocations, enhancing returns on invested funds, and managing cash flows to meet the spending needs of the University from endowment and other funds.

The Foundation has a subsidiary corporation called Bengal Pharmacy, LLC (the Pharmacy). The Pharmacy was formed as a limited liability company (LLC) with the Foundation as the sole member. (Continued on Schedule O)The Pharmacy was formed to serve students, administrative staff and faculty being seen at the student health center as well as patients of the Idaho State University (ISU) residency program. The residency program treats patients of a local Federally Qualified Health Center including those who qualify for discount drug purchases under Section 340b of the Public Health Service Act. The pharmacy has expanded its original mission to support ISU's rural health mission by opening tele-health pharmacy locations in Arco, Kendrick, and Challis, Idaho. In addition, students are employed and trained in the pharmacy on many aspects of pharmacy practice, including dispensing and clinical projects such as medication therapy management and medication synchronization. Fourth year students also do pharmacy rotations as part of their training. ISU also has PharmD/MBA seeking students in rotations for the business side of pharmacy operations. Pharmacy Residents are part of an ISU post-graduate training program.
