Visitors personalize the discussion and provide parents with resources and tools that support their individualized parenting questions and concerns. Volunteers and staff meet parents at home, at work, in groups or at any community setting of their choice. Often, Bright by Three partners with community agencies to offer our programs to parents. Parents and caregivers can also receive Bright by Three's program content and other resources via "Bright by Text", which sends bite-sized concepts and activities timed to the developmental stage of the child.
