The 2017-18 school year was another of growth for THA as an organization. Enrollment ended the year at 147 students, down from the previous years high of 159, due largely to graduating 23 8th graders in May of 2017. Fourteen students and three chaperones attended the annual Israel Experience trip, traveling to Israel in May. Upper School Humanities saw positive changes through the collaboration of new and existing staff members. THA continued to build on the work with Gifted and Talented students begun in 2015-16. A second year of grant funding received allowed for sustained programming in the Orthodox Jewish education track. Two additional classrooms received updated Smartboards, allowing for enhanced instructional opportunities. In March, THA hosted the fifth annual STEM Festival, the largest in southern Arizona, connecting over 40 science, technology, engineering, and math vendors and researchers with 1,500+ attendees. The THA organization continues to improve the infrastructure that supports our students learning. During the 2017-18 school year, updates included a new fire suppression and notification system, updated group restrooms, exterior building paint, a solar array installation, and updated HVAC units and roof covering. The organizations largest single fundraising event, Tikkun Olam, exceeded both the expected attendance and financial goals. New staffing included a new Marketing and Community Outreach Coordinator and the continuation of the Shlichim program, an exchange program for educators from Israel. THA continues to grow and change to meet the needs of our student population, while creating an environment for learning that strongly supports our established mission.
