Neither the Executive Committee, nor any other committee created by the Board, shall have the authority to: (a) amend, alter or repeal these Bylaws, (b) appoint or remove any member of the Executive Committee or any director or officer of the Corporation, (c) amend or restate the Articles, (d) adopt a plan of merger or consolidation with another corporation, (e) authorize the sale, lease, exchange or mortgage of all, or substantially all, of the property and assets of the Corporation, (f) authorize the voluntary dissolution of the Corporation or adopt a plan for the distribution of the assets of the Corporation or (g) amend, alter or repeal any resolution of the Board.
