WE USED AN OUTSIDE CONSULTANT TO DO THE ANALYSIS AND PRICING FOR THE PRESIDENT/CEO POSITION. A COMPENSATION ANALYSIS AND RECOMMENDATION WAS PREPARED FOR THE CHAIR OF THE BOARD WHO PRESENTED TO THE EXECUTIVE COMMITTEE. THE COMMITTEE REVIEWED AND APPROVED THE CEO SALARY INCREASE. MILLIMAN, LEADING AGE, HOME HEALTH SALARY SURVEYS AND JUDGEMENT WERE USED TO PRICE THE SALARIES OF THE OTHER OFFICERS. THE HR DEPARTMENT PROVIDED THE ANALYSIS AND THE PRESIDENT/CEO MADE THE FINAL DETERMINATION.
