Palliative care is a specialty focused on individuals with a serious illness that are experiencing difficulty coping with symptoms, stress and uncertainty The experienced palliative care team provides guidance and support focused on relieving physical, emotional, or spiritual suffering for those affected by a serious or complex illness While utilizing palliative care services, patients experience comfort and an enhanced quality of life and may continue seeking curative treatment for their disease CPE/Professional Training - The Chaplaincy offers Clinical Pastoral Education (CPE) for professional Chaplains, lay people and spiritual caregivers who provide community caregiver education and training It is comprised of two 24 week extended (part time) units a year Our Center has been a nationally accredited Clinical Pastoral Education training center for over 30 years Chaplains trained here have been successful in getting their professional certification and working in health care systems throughout the Northwest Cork's Place - Provides a safe and nurturing place where hurting children, teens and families can share experiences and support one another through the difficult process of emotional healing It is staffed by professional grief counselors and trained volunteers and is the only facility in our area that is specifically designed for children and teenagers who are grieving the death of a loved one Other programs include bereavement groups and community outreach
