Education and Training - Provided and supported character-based education and business training programs in East Asia, and beyond. Recruited, trained and sent 83 teachers and field staff (foreign and national) to seven international schools (Pre K 12), with just over 2,300 students from more than 50 countries, and to business training and coaching programs in three major cities in Asia. Outreach for intensive character-based teacher training reached over 520 participants. Character-based experiential education reached 380 participants. Character-based business training and coaching reached 870 participants. Intensive leadership formation program reached over 20 participants. Approximately 20 volunteers, including seconded staff from other non-profit organizations, serve the organization.
