THE BOYS AVERAGE 7.8 PREVIOUS PLACEMENTS PRIOR TO ADMISSION TO THE RESIDENTIAL TREATMENT PROGRAM. THE RESIDENTIAL TREATMENT PROGRAM HAS A FOUR YEAR 80% KEY INDICATOR SUCCESS RATE AT ONE YEAR FOLLOWING PROGRAM COMPLETION. DAY TREATMENT SERVICES - THE DAY TREATMENT PROGRAM SERVED 42 BOYS WITH AN AVERAGE AGE OF 14.2 YEARS AND A LENGTH OF STAY OF 1.8 YEARS. THE DAY TREATMENT PROGRAM PROVIDES MENTAL HEALTH SERVICES THROUGH REFERRAL FROM SURROUNDING SCHOOL DISTRICTS AND INCORPORATES THE NEEDS IDENTIFIED IN EACH BOY'S INDIVIDUALIZED EDUCATION PROGRAM.
