6. WE WILL PROVIDE CONSISTENT RESPONSES TO SIMILAR CONSERVATION EASEMENT VIOLATIONS;
7. AT ALL TIMES, WE WILL ACT IN A MANNER THAT MAINTAINS THE LAND TRUST'S PROFESSIONALISM, CREDIBILITY, AND INTEGRITY.
