THE SURGEON GENERAL FOR CALIFORNIA, KEYNOTE SPEAKER AT THE 2020 FCHIP STATE OF OUR H EALTH BREAKFAST, INTRODUCED AN INITIATIVE AIMED AT RAISING AWARENESS OF ADVERSE CHILDHOOD EXPERIENCES (ACES). THE ACES AWARE INITIATIVE WAS MEANT TO ENGAGE THE MORE THAN 300 PEOPLE IN ATTENDANCE, INCLUDING HEALTH CARE PROVIDERS, NON-PROFIT AGENCY LEADERS, TEACHERS, AND ELECTED OFFICIALS, IN ADDRESSING THE NEEDS OF FAMILIES EXPERIENCING LONG-TERM TRAUMA. THE BREAKFAST HELPED GARNER FUNDING FROM THE STATE FOR FRESNO TO TRAIN PROVIDERS ON ASSESSING FOR ACES AND FOR AGENCIES TO INCREASE AWARENESS THROUGHOUT FRESNO COUNTY. ECONOMIC SECURIT Y, INCLUDING HOMELESSNESS - ECONOMIC SECURITY IS A NEED MARKED BY A RATE OF POPULATION WIT HOUT A HIGH SCHOOL DIPLOMA THAT IS NEARLY 10.5% GREATER THAN THE STATE AVERAGE; POPULATION RECEIVING PUBLIC ASSISTANCE THAT IS MORE THAN 3.5% HIGHER THAN THE STATE AVERAGE; HIGH PE RCENT OF POPULATION LIVING IN POVERTY; AND A GROWING NUMBER OF HOMELESS PEOPLE LIVING IN T HE AREA. TWENTY-FIVE PERCENT OF PEOPLE SURVEYED IN THE NEEDS ASSESSMENT VOICED THEIR CONCE RNS OVER ECONOMIC/HOMELESSNESS ISSUES. ACCORDING TO THE 2020 POINT-IN-TIME COUNT (THE ANNU AL COUNT OF THE REGION'S SHELTERED AND UNSHELTERED HOMELESS INDIVIDUALS AND FAMILIES) THE HOMELESS COUNT WAS 3,641. THIS AMOUNT REPRESENTS AN INCREASE OF 45% OR 1,133 HOMELESS INDI VIDUALS IN COMPARISON TO THE 2019 COUNT OF 2,508.SAMC SUPPORTS THE COORDINATED EFFORT TO A DDRESS HOMELESSNESS BY INVESTING IN NONPROFIT COMMUNITY ORGANIZATIONS WORKING TO END THE C YCLE OF HOMELESSNESS. PARTNER ORGANIZATIONS WORKED TO PROVIDE IMMEDIATE HOUSING AND WRAP-A ROUND SERVICES TO INDIVIDUALS, FOR MORE STABILITY AND SUPPORT FOR LONG-TERM SUCCESS. MORE THAN 1,800 HOMELESS PATIENTS IN THE EMERGENCY DEPARTMENT WERE PROVIDED MEALS, CLOTHING AND RESOURCES AT NO COST. SAMC PLAYED A CRITICAL ROLE IN EFFORTS TO END HOMELESSNESS BY EITHE R FINANCIALLY SUPPORTING AND/OR SERVING ON THE BOARD OF FRESNO HOUSING, THE POVERELLO HOUS E, AND THE ADVISORY COMMITTEE FOR THE FRESNO-MADERA CONTINUUM OF CARE. THE WORK OF THESE O RGANIZATIONS AND INITIATIVES HAS GARNERED MORE THAN \$13 MILLION TO COMBAT HOMELESSNESS. IN FISCAL YEAR 2020, SAMC CONTINUED TO SUPPORT THE HOLY CROSS CENTER FOR WOMEN (HCCW), WHICH IS FRESNO'S ONLY LOCAL DAY-SHELTER. SINCE THE LAST CHNA, THE CENTER HAS PROVIDED A SAFE H AVEN TO AN AVERAGE OF 644 WOMEN PER MONTH AND DAY CARE TO 12 CHILDREN PER MONTH. THE FACIL ITY PROVIDED 6,049 PEOPLE WITH LAUNDRY SERVICES, SHOWERS, BUS TOKENS AND HAIRCUTS, AND 4,2 83 WOMEN WITH EMERGENCY CLOTHING AND DIAPERS. MORE THAN 4,297 WOMEN WERE PROVIDED WEEKLY P ROGRAMS SUCH AS ENGLISH SECOND LANGUAGE (ESL), SEWING INSTRUCTION, AND "YOU ARE WORTHY". T HESE PROGRAMS PROVIDE WOMEN THE OPPORTUNITY TO DEVELOP A SUPPORT SYSTEM AND BEGIN TO FEEL GOOD ABOUT THEMSELVES. THE HCCW IS NOT AN OVERNIGH</p>

A TOTAL OF 3,596 CHILDREN WERE ENGAGED IN THESE PROGRAMS IN FISCAL YEAR 2020. PEOPLE WHO ARE MEDICALLY VULNERABLE AND WHO FACE SOCIAL CHALLENGES WITH RESOURCES SUCH AS PRIMARY CARE, SPECIALTY CARE, INSURANCE ENROLLMENT, TRANSPORTATION, HOUSING, AND OTHER SOCIAL RESOURCES HAVE A MUCH MORE DIFFICULT TIME MANAGING THEIR HEALTH. SAMC'S EFFORTS EXTENDED BEYOND ITS OWN TOBACCO-FREE CAMPUS TO PROVIDE FINANCIAL SUPPORT TO THE AMERICAN HEART ASSOCIATION TO RAISE AWARENESS REGARDING HEART HEALTH, THE DANGERS OF TOBACCO, AND THE IMPORTANCE OF SMOKING CESSATION. SAMC ALSO PROVIDED TRAINING TO LEADERS AND PROVIDERS TO FACILITATE THE COURAGE TO QUIT PROGRAM TO PATIENTS AND COMMUNITY MEMBERS, AND COUNSEL TO QUIT PROGRAM TO PATIENTS. ADDRESSING SOCIAL INFLUENCERS (DETERMINANTS) OF HEALTH - ACCORDING TO HEALTHY PEOPLE 2020, FOOD INSECURITY CAN INCREASE THE RISK FOR OBESITY, CHRONIC ILLNESSES, AND MENTAL HEALTH CHALLENGES. SAMC PROVIDED FINANCIAL SUPPORT TO COMMUNITY-BASED ORGANIZATIONS IN A SOCIAL INFLUENCER OF HEALTH INITIATIVE FOCUSED ON FOOD INSECURITY. ALSO, BY FUNDING THE FRESNO MEAL EXPRESS PROGRAM, MORE THAN 80 FAMILIES LIVING IN RURAL AREAS OF FRESNO COUNTY HAD ACCESS TO HEALTHIER MEALS. SEE CONTINUATION OF LINE 5 AT THE END OF PART VI.</p>

AS A RESULT, NEIGHBORHOOD ASSOCIATIONS FOR CHANGE WERE ESTABLISHED IN 15 SCHOOLS, WITH 670 RESIDENTS. LEADERSHIP DEVELOPMENT COHORTS TRAINED 34 PARTICIPANTS ON UNDERSTANDING RACIAL CONFLICT, EQUITY AND STRUCTURAL RACISM, ADVOCACY, AND POLICY CHANGE. SAMC ACKNOWLEDGES THE WIDE RANGE OF PRIORITY HEALTH ISSUES THAT EMERGED FROM THE CHNA PROCESS AND DETERMINED THAT IT COULD EFFECTIVELY FOCUS ON ONLY THOSE HEALTH NEEDS WHICH IT DEEMED MOST PRESSING, UNDER-ADDRESSED, AND WITHIN ITS ABILITY TO INFLUENCE. SAMC COMMITS TO CONTINUOUS MONITORING OF SERVICE AREA RESIDENTS' HEALTH STATUS, GAINING A COMPREHENSIVE UNDERSTANDING OF LOCAL SERVICE AREA SOCIAL AND ECONOMIC ISSUES, AND CREATING/FOSTERING RELEVANT PARTNERSHIPS WITH LOCAL COMMUNITY BENEFIT ORGANIZATIONS TO MAKE THE GREATEST IMPACT ON HEALTH IN THE COMMUNITY. IN FY20, SAMC DID NOT TAKE ACTION ON THE FOLLOWING HEALTH NEEDS: - MATERNAL AND INFANT HEALTH - SAMC DID NOT DIRECTLY ADDRESS THIS NEED DUE TO COMPETING PRIORITIES. HOWEVER, WE CONTINUE TO USE BABY-FRIENDLY BEST PRACTICES. - ORAL HEALTH - SAMC DID NOT ADDRESS THIS NEED BECAUSE WE DO NOT HAVE ORAL HEALTH EXPERTISE IN-HOUSE. - VIOLENCE AND INJURY PREVENTION - SAMC DID NOT ADDRESS THIS NEED BECAUSE THERE ARE LIMITED OPPORTUNITIES TO LEVERAGE EXISTING INTERNAL AND EXTERNAL EFFORTS IN THIS AREA. ADDITIONALLY, SAMC DID NOT DIRECTLY ADDRESS THE FOLLOWING NEEDS BECAUSE THEY ARE RANKED AS A LOWER PRIORITY IN THE CHNA: CLIMATE AND HEALTH, CVD/STROKE, ASTHMA, HIV/AIDS/STIS, AND CANCER.</p>
