Typically, the distribution supports new San Francisco Ballet works and productions, the Ballet's orchestra and music, artistic innovation, touring, dance education, scholarships, and the San Francisco Ballet School. Depending upon market conditions and the needs and available resources of the Association, appropriations for expenditure from individual endowments may be temporarily suspended to facilitate preservation of the endowment.
