resolution of complaints, including allegations of elder abuse and violations of residents' rights Senior Nutrition Program offers socialization and hot nutritious meals for seniors (age 60 and over) five days a week at Catholic Charities Eastside Neighborhood Center and John XXIII Multi-Service Center in San Jose Senior Programs at Neighborhood Centers offers educational classes, recreation and the Diocese with responsibility as the lead agency for long-term recovery and disaster case management services for the County of Santa Clara, including San Jose The program assists survivors of the 2017 San Jose Coyote Creek Flood in finding temporary to permanent affordable housing, fulfills unmet needs, provides recovery planning, and helps clients reach self-sufficiency The program also works to create preparedness for future disasters
