TED also holds smaller themed conferences and events throughout the year, educating and broadcasting important new knowledge and ideas to attendees and to the world at large. Preparation for each event involves a deliberate and profoundly rigorous research process to curate speakers, and ensure that all content is accurate, informative and clearly delivered.

All TED's conferences provide a singular and unprecedented forum for public discourse, education and the exchange of new research, ideas and emerging knowledge across multiple disciplines in the sciences, social sciences, media, arts, technology, medicine and the humanities. The best TEDTalks and materials from our conferences are carefully selected by our media research team, published on our website and made available online to the public for free, in multiple languages, attracting a global audience in the millions.

**PROGRAM 2 – TED Fellows program**

TED deploys a dedicated staff of onsite researchers and analysts as well as external fact-checkers, thought leaders and experts, who collectively determine each submission's level of innovation, expertise and potential for impact. Upon selection, TED Fellows are trained by world experts in the most effective ways of knowledge-sharing and spreading great ideas with a view to participating in our annual TED Conference and presenting their own TED Talk, researched, thoroughly fact-checked and written over the course of several months.
