Enclosed with the checks are the name(s) of the student(s) for whom the check should be credited for, their date of birth, check number and amount. In addition, Pauahi Foundation sends the award check to the educational institution to avoid any misuse. However, there is one scholarship fund in which the awards are made directly to the students, in which case Pauahi Foundation advises the recipients in a written letter that the funds are to be used for their educational expenses.
