Transitional Shelter Care Program (TSC) - The TSC is a shelter care program for Department of Child and Family Services, (DCFS), youth who are in need of placement and cannot be placed right away, usually due to being so difficult in placement. We have 10 beds for female adolescents ages 11-17 and 6 beds for female non-minor dependents (NMD) ages 18-20 and their dependent children if they have any with them. By law, they are supposed to be placed by Los Angeles County into placement within 72 hours, but that often does not happen because of the high needs of these youth. During the year covered, 242 youth were served.
