This year was a record-breaking year for St. Francis Center (SFC) in terms of food rescued and families served. SFC rescued 1.3 million pounds of food which allowed them to provide 130,000 homeless meals and over 18,000 grocery visits to families struggling with food insecurity - that's more than ever in its 45-year history. The addition of new food donation partners like Target, Costco and Trader Joe's allowed SFC to expand to two satellite pantries at schools and serve more families in need. SFC also added a new case management component helping 45 families avoid homelessness with rental and utilities assistance. 100% of the families served live well below the federal poverty level earning on average just under \$12,000 annually for a family of four.

Form 990, Part III, Line 4b:

SFC not only served over 130,000 homeless meals, but also for the first time began providing case management services to help homeless guests access emergency shelter, housing, and employment. The expansion of SFC's shower facility helped to provide 3,285 guests with shower, health, and hygiene visits, double the amount of the previous year. Our diverse volunteer base helped support our small team of 12 staff with over 2,600 volunteers donating over 2,600 hours of service. Other programs offered to our homeless community include mail services, computer and phone access, resource and referral services. With additional support, SFC hopes to continue to focus on expanding its Homeless Well Being Programs for the coming year.
