This year was a record-breaking year for St. Francis Center (SFC) regarding the amount of food we recovered and the number of guests we served. We rescued 1.5 million pounds of food, which allowed us to provide 100,000 homeless meals (more than double what we were serving six years ago) and over 22,000 grocery visits to families struggling with food insecurity - that's more than ever in our 47-year history. The addition of new food donation partners including Trader Joe's, Target, Costco, Banc of California stadium, LA Coliseum, Worldwide Produce and more allowed SFC to expand to three satellite pantry sites now including USC and LA Trade Tech College to provide free, fresh, nutritious groceries for food-insecure students.

SFC continues to incorporate comprehensive services into our homeless program offerings to help end the cycle of poverty and provide health and stability for our guests. In addition to our soup kitchen and food pantry, SFC provides health and hygiene services and resource referrals.
