This year was another successful year for St. Francis Center regarding the amount of food we recovered and the number of guests we served. We rescued 1.3 million pounds of food, which allowed us to provide 100,000 homeless meals (more than double what we were serving seven years ago) and over 30,000 grocery visits to families struggling with food insecurity - that's more than ever in our 47-year history. The addition of new food donation partners including Trader Joe's, Target, Costco, Banc of California stadium, LA Coliseum, Worldwide Produce, Food Forward and more allowed SFC to expand to five satellite pantry sites now including Homeboy Industries, Hubert Humphrey Comprehensive Health Center, USC, South Central LAMP and LA Trade Tech College to provide free, fresh, nutritious groceries for food-insecure students.

SFC has been working toward providing more comprehensive services to help end the cycle of poverty for guests. Our health & hygiene services and resource services have been aimed at providing health and stability for our guests. Our case management program provides housing, rental and utility assistance which allowed us provide Resource Services to a total of 1,583 guests (131 per month) and one-on-one case management for 47 guests. Our goal is to strengthen the impact of these programs and make them available to more guests in need.
