*While your payroll deduction for Perq will still be equal to the list price, using pre-tax money means that you'll end up with more money in your pocket than paying at a vending machine or ticket window. Talk with your payroll administrator to determine how your deduction will work. Federal rules limit tax-free monthly spending to \$260, while state levels can vary. Responsibility for the tax status of your deduction ultimately falls on employers.
