

## MAXXON CORPORATION COMMERCIAL WARRANTY

### WHAT PRODUCTS ARE COVERED?

Subject to the terms of this Limited Lifetime Warranty, Maxxon Corporation ("Maxxon") warrants that materials sold by Maxxon ("Maxxon Materials") will be free from defects in the manufacture of the materials. This warranty is specific to the installation of the Maxxon Commercial PRO and Commercial product lines. It expressly includes and is limited to the Maxxon® Commercial PRO and Commercial product lines, when installed in accordance with Maxxon instructions. For limited lifetime warranty, Maxxon requires the installation of a Maxxon Commercial moisture vapor primer or barrier and a Maxxon Commercial or Commercial PRO underlayment or patch over the entire concrete slab in accordance with Maxxon instructions, if moisture levels are above floor covering manufacturers' requirements.

### HOW LONG DOES COVERAGE LAST?

This Limited Warranty extends for the life of the floor coverings when used within the limitations established by the flooring manufacturer. This Limited Warranty only applies to the owner of the premises at the time the Maxxon Materials are installed.

### WHAT IS NOT COVERED?

This Limited Lifetime Warranty does not apply in the case of any of the following:

- Installation of non-Maxxon or S3 Surface Solutions products as part of system solution.
- Installation not in accordance with Maxxon's instructions and applicable industry standards, guidelines and building codes
- Inferior installation workmanship
- Modified Maxxon Materials
- Mishandling, misuse or improper storage of Maxxon Materials
- Issues arising due to weather and environmental conditions
- Improper substrate preparation
- Defects due to structural movement, structural design flaws, excessive deflection or other failure in the substrate
- Maxxon Materials included in floor underlayment installations not exclusively using Maxxon Materials if Maxxon offers a similarly purposed product
- Improper maintenance and abuse of installed Maxxon Materials
- Improper maintenance and abuse of installed floor coverings, defined as exceeding the limitations outlined by the flooring manufacturer
- Defects, damage or other harm that is not the result of material defects in the manufacture of the Maxxon Materials

The Maxxon Materials are supplied on an "AS IS" basis when any of the foregoing apply. **TO THE EXTENT PERMITTED BY LAW, ALL EXPRESS AND IMPLIED WARRANTIES (INCLUDING IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, DESIGN AND NON-INFRINGEMENT), OTHER THAN THE EXPRESS LIMITED WARRANTY SET FORTH ABOVE, ARE EXPRESSLY DISCLAIMED. UPON THE EXPIRATION OF THE ABOVE STATED LIMITED WARRANTY PERIOD, ANY AND ALL APPLICABLE IMPLIED WARRANTIES THAT MAY NOT BE DISCLAIMED ALSO EXPIRE.**

Maxxon specifically disclaims the results of the installed Maxxon Materials because Maxxon does not install the Maxxon Materials or determine the suitability of the Maxxon Materials for the specific application, regardless of Maxxon's statements, publications, advice, instruction, and involvement in the installation. No employee, representative or agent of Maxxon has authority to bind Maxxon, and no other written statement binds Maxxon, to any affirmation, representation or warranty other than as stated in this Limited Warranty unless it is in writing and signed by an authorized officer of Maxxon.

#### **HOW DO I GET SERVICE**

**A copy of this warranty along with receipt of materials purchased, must be submitted to Maxxon Corporation. Once received, Maxxon will generate verification of receipt and of the warranty. This will be e-mailed to the listed contacts.**

Any claim against Maxxon must be submitted in writing within thirty days after discovery of the potential defect and received by Maxxon at 920 Hamel Road, Hamel, MN 55340 prior to the expiration of the above stated Limited Warranty period or is forever waived. Maxxon must be given a reasonable opportunity to inspect and investigate the alleged defective Maxxon Materials prior to any work being done that affects the Maxxon Materials or their installation.

#### **LIMITED WARRANTY REMEDY**

In the event of a warranty claim that Maxxon determines to be covered by this Limited Warranty, Maxxon will, at its option, (a) supply replacement Maxxon Materials, or (b) refund the purchase price actually paid to Maxxon for the defective Maxxon Materials prorated against the warranty as expressed by the floor covering manufacturer. The terms and limitations of this Limited Warranty apply to any replacement Maxxon Materials supplied with the Limited Warranty term being equal to the balance of the remaining warranty on the initial supplied Maxxon Materials. Costs of de-installation and re-installation of the floor underlayment, floor covering material and any other direct and indirect damages are covered by this Limited Warranty.

The remedies set forth in this Limited Warranty are the exclusive remedies for which Maxxon is liable and Maxxon shall have no other liability to any other person or entity. Any efforts by Maxxon beyond the obligations provided for in this Limited Warranty will not in any way change or extend the limitation of remedies and damages stated in this Limited Lifetime Warranty. In no event will Maxxon's liability to any person or entity exceed the price paid to Maxxon for the defective Maxxon Materials. MAXXON SHALL NOT HAVE ANY LIABILITY TO ANY PERSON OR ENTITY FOR CONSEQUENTIAL, INCIDENTAL, OR OTHER INDIRECT DAMAGES OF ANY DESCRIPTION OR TYPE. The above Limited Lifetime Warranty and stated remedy is the sole warranty and remedy provided by Maxxon and agreed upon allocations of risk.
