**INSTALLATION** Membrane where the tape is to be applied must be cleaned to a “like new” condition. Failure to properly clean the membrane will result in less than satisfactory adhesion. Do not apply Perimeter Warning Tape when the temperature is below 40 degrees Fahrenheit.  
Perimeter Warning Tape may be slippery when wet.

**AVAILABILITY** From Sika Corporation – Roofing Authorized Applications for use within Sarnafil or Sikaplan systems.

**MAINTENANCE** Standard maintenance of Sarnafil or Sikaplan systems should include regular inspection of flashings, drains, and termination sealants at least twice a year and after each storm.
