RhinoBond PS Cardboard Disc is a round coated cardboard disc used in the installation of Sarnafil® S 327 or Sikaplan® RhinoBond roofing systems. It is intended to protect Sika approved polystyrene fanfold roofing underlayments from heat during the induction welding process.

### SYSTEM INFORMATION

#### INSTALLATION

Position the RhinoBond PS Cardboard Disc on the surface of the Sika approved fanfold roofing underlayment at the designated spacing. Center the Sarnadisc RhinoBond plate over the RhinoBond PS Cardboard Disc so the center holes are aligned. Insert the Sika approved fastener through the center holes and fastened to the approved roof deck, clamping the fanfold roofing underlayment in place.

**MAINTENANCE**

Standard maintenance of Sarnafil or Sikaplan systems should include regular inspection of flashings, drains, and termination sealants at least twice a year and after each storm.
