#### COMPOSITION

Sarnadisc is a 20 gauge (0.9 mm), 2 in (51 mm) diameter SAE 1010 steel plate with an AZ 55 Galvalume coating to meet Factory Mutual 4470 criteria for corrosion resistance.

#### DIMENSIONS

Diameter: 2 in (51 mm)

Sarnadisc is packaged in boxes of 1000 discs. Each box weighs approximately 29 lbs (13 kg).

**INSTALLATION** Sarnadisc is positioned on the surface of the Sarnafil S 327 membrane and a Sarnafastener is placed through the center of it and then set into the roof deck, clamping the Sarnafil S 327 membrane in place.

---

**AVAILABILITY** From Sika Corporation – Roofing Authorized Applications for use within Sarnafil or Sikaplan systems.

---

**MAINTENANCE** Standard maintenance of Sarnafil or Sikaplan systems should include regular inspection of flashings, drains, and termination sealants at least twice a year and after each storm.

---
