<b>INSTALLATION</b>	Sikaplan Board Plate is positioned on the surface of the insulation board. A Sikaplan fastener is set through the center of it and drilled into the roof deck. The Sikaplan Board Plate clamps the insulation board in place.
<b>AVAILABILITY</b>	From Sika Corporation – Roofing Authorized Applications for use within Sikaplan systems.
<b>MAINTENANCE</b>	Standard maintenance of Sarnafil or Sikaplan systems should include regular inspection of flashings, drains, and termination sealants at least twice a year and after each storm.
