Vapor Retarder Primer SB has a shelf life of up to 60 months in the original sealed container stored in a cool ventilated area.

APPLICATION INSTRUCTIONS

SURFACE PREPARATION

All surfaces should be clean, dry, free of dirt, dust, debris, oils and other contaminants.

MIXING

Vapor Retarder Primer SB must be mixed well before use. Do not dilute.

APPLICATION

Apply the primer with a brush or roller and allow primer to dry completely before applying Sika's self-adhered vapor retarder or Sarnafil G476 SA waterproofing membrane. Install Sika's self-adhered vapor retarder or Sarnafil G476 SA on the same day as the application of Vapor Retarder Primer SB.

COVERAGE

The coverage rate will range from 83 - 138 sf/gal (0.3 – 0.5 L/m²) on porous surfaces to 166 - 416 sf/gal (0.1 – 0.25 L/m²) on non-porous surfaces.

PRODUCT LIMITATIONS

LIMITATIONS

Precautions should be taken to prevent odors and/or vapors from entering the building/structure, including but not limited to turning off and sealing air intake vents or other means of ingress for odors and/or vapors into the building/structure during product application and cure.

- The minimum ambient and surface temperatures should be 14°F (-10°C) and rising.
 - Vapor Retarder Primer SB is a flammable product. Do not accelerate drying of Vapor Retarder Primer SB by heating it with a torch. Keep ignition sources away during application and until solvent has evaporated.
 - In closed area, ventilate carefully using mechanical means if necessary.
 - Do not use Vapor Retarder Primer SB to seal self-adhesive vapor retarder seams or overlaps.
