## TRANSIENT VENDOR REGISTRATION APPLICATION

Per Orange Township Resolution 18-083 and in accordance with ORC 505.94, Transient Vendors must submit a Transient Vendor registration and be issued a Registration Certificate by Orange Township prior to solicitation to any Orange Township residential address.

Orange Township maintains a "Do Not Knock Registry" onto which Township residents may voluntarily request their address be added. This registry shall be provided to Transient Vendors with their Registration Certificate and is also available on the Township website, www.orangetwp.org. Solicitation is prohibited at any residence at which the owner or tenant has posted a sign on the property prohibiting solicitation and/or at those addresses listed on the "Do Not Knock" list.

Orange Township prohibits solicitation between the hours of 8:00 PM and 9:00 AM on Sundays and on legal holidays as defined by ORC 1.14. Pursuant to ORC 505.94, no Transient Vendor shall fail to register or comply with the regulations set forth in Resolution 18-083. Violations shall be punishable as provided in ORC 505.99. Penalties shall be imposed in accordance with applicable section(s) of the Ohio Revised Code.
