Pool Rules

General

- All visitors must obey pool management and lifeguards. They are present for visitor safety and to enforce rules so that all visitors may enjoy the benefits of the North Orange Aquatic Center.
- At all times, children of the age of 12 years or younger will not be permitted upon the North Orange Aquatic Center grounds unless under the direct care and supervision of a parent or other responsible person of the age of 16 years or older.
- Ten-minute rest periods will be taken every hour. Only adults (18 years of age and older) and infants or toddlers in the arms of an adult are permitted in the pool during rest periods.
- Pets are not permitted within the pool or upon the adjacent North Orange Aquatic Center grounds.
- Children who are not potty trained are required to wear swim diapers, or "swimmies". No exceptions.
- Proper swim attire is required at all times. Topless female visitors, thongs and cut-off jeans are prohibited in the pool.
- Running, pushing, dunking, rowdy behavior, wrestling, splashing, throwing objects, holding anyone under water and the use of inappropriate or foul language anywhere within the North Orange Aquatic Center is prohibited.
- Soft "Nerf-type" balls and United States Coast Guard-approved floatation devices are the only objects permitted in the pool.
- No water guns, skateboards, rollerblades, roller skates, or bicycles are permitted within the Aquatic Center.
- Glass containers are not permitted within Orange Township Parks.
- All food and beverages must be kept away from the immediate pool area.
- Any bags or coolers brought into the North Orange Aquatic Center are subject to inspection.
- Use of intoxicants and/or smoking (including vaping) is prohibited within, or adjacent to the North Orange Aquatic Center.
- Loitering in the restrooms, changing facilities, locker area, pool entry, and/or parking lot is not permitted.
- Visitors are responsible for any damage to the North Orange Aquatic Center or premises caused by themselves, their families, or their guests. Management and Orange Township are not responsible for the loss or theft of, or damage to, personal property or vehicles of visitors, their families, or guests.
- All persons using the North Orange Aquatic Center do so at their own risk. Management and Orange Township will not be responsible for any injury, accident, or damage in connection with such use. All injuries, accidents, or damage should be reported immediately to the pool manager on duty.

Organized Groups

- Upon arriving at the pool, organized groups of children under the age of 15 years ("organized groups") must check in with pool management and notify them of the group's arrival's.
- Organized groups must provide chaperones to assist in monitoring group members. Chaperones must be at least 16 years of age. The number of chaperones required to be provided shall be as follows:
- Children 5-12 years of age: 1 chaperone per 6 children attending;
- Children 4 years of age and under must all be within an arm's reach and/or in the arms of a chaperone.
- Group members who have not passed a swim test (administered by the group) must wear a red wristband (provided by the group).
- Group members who have passed the swim test must have a chaperone within 3 feet of the edge of the pool and actively watching and supervising the group members.
- Chaperones are required to be attentive to the group members in the water, and are required to keep their eyes on group members at all times.

Rule Violation or Misconduct

Violation of these rules or regulations or any other misconduct may result in a temporary or permanent suspension of pool privileges.
