**Variance Application #VA-23-17 Meaghan O'Connor,**

Seeking two Area Variances from the Orange Township Zoning Resolution Section 21.09 for a commercial building to encroach into the allowed seventy (70) and thirty (30) feet setbacks, respectively. Also requesting an Area Variance from Section 21.01 to allow for a daycare to have fewer parking spaces than the required one (1) space per employee plus one (1) space for every five (5) children in a Planned Commercial and Office (PC) District. **Variance Application #VA-23-19 3-Pillar Homes c/o Daniel Griffin,**

Seeking an Area Variance from Rezoning Case #ZON-22-04 Evans Farm to establish the front building setback along a private alley in a Single Family Planned Residential (SFPRD) District. The subject property is located at 2331 Linden St., Lewis Center, Ohio 43035 and having parcel number 318-210-20-003-000.
