# **INCOTERMS® 2020**



## International **Commercial Terms**

#### General Information

INCOTERMS® 2020 should be set in the purchasing or sales agreement, but may vary on an order-byorder basis. It is important that all participants in the process be aware of the impact when establishing INCOTERMS® Rules. Preferred INCOTERMS® may vary based on the mode of transport (Air vs. Ocean), the regions involved (Asia vs. North America, for example), the role of the parties involved, the commodity being bought or sold, and the terms of sale.

#### Risk, Cost, & Responsibility

INCOTERMS® Rules dictate the transfer of risk and responsibility, as well as which party is responsible for specific aspects of the transaction - including the payment of duties, the import and export clearance of the goods, the arrangement and payment of freight, and more.

### **Title Transfer**

Title transfer is not governed by INCOTERMS® 2020; transfer of title is established in the purchasing or sales agreement, or as specified in the Terms and Conditions Contract.
