REPRESENTATIVE OF ATHLETICS INTEREST

A Representative of Athletics Interest is an individual who is known (or should have been known) by a member of the institution's executive or athletic administration to:

- A. Have participated in or to be a member of an agency or organization, including corporate entities promoting the institution's intercollegiate athletics program;
- B. Have made financial contributions to the athletics department or to an athletics booster organization of the institution;
- C. Be assisting or to have been requested (by the athletic department staff) to assist in the recruitment of prospective student-athletes;
- D. Be assisting or to have assisted in providing benefits to enrolled student -athletes or their families;
- E. Have been involved otherwise in promoting the institution's athletic program; or
- F. Have participated as a varsity student -athlete at the University.

*Once an individual is identified as a representative of athletics interest, he/she retains that identity indefinitely.

As a Representative of Athletics Interest you are **PROHIBITED** from:

- Making in-person, off-campus recruiting contacts with prospective student-athletes.
- Making telephone calls to prospective student athletes or his/her parents (legal guardians).
- Making arrangements for a prospect or the prospect's relatives or friends to receive money or financial aid of any kind.
- Providing transportation for a prospect or the prospect's relatives or friends to visit our campus.
- Providing free tickets or tickets at a reduced cost for prospects or the prospects relatives or friends to attend an athletic event/function.
- Entertaining high school, prep school or community college coaches.
- Providing honorarium to a student-athlete for a speaking engagement.
- Providing free or reduced rent-housing.
- Providing special discounts for goods and services (ex: car repairs, legal services, meals).
- Providing gifts of any kind, including birthday cards, gift cards and holiday gifts.
- Providing cash or loans in any amount, or signing or co-signing for a loan.

As a Representative of Athletics Interest you are **PERMITTED** to:

- Notify our coaches about prospects in your area that may be strong additions to our teams.
- Attend high school or two-year college contests or other events where prospects may compete; however, you may NOT contact the prospect or the prospect's relatives.
- Continue existing friendships with families of prospects, but you may NOT attempt to recruit the prospect.
- Invite a student-athlete or team into your home for an occasional meal, but please coordinate such activity with the compliance office.
- Make donations to DSU Athletics.
- Provide summer employment for enrolled student-athletes with appropriate documentation on file with the compliance office.
