Tournament Rules

1. Waiver of Liability must be read/signed by each player prior to start of 1st game
2. Coin flip will determine who starts with the ball first
3. Games will be played to 15 by 1's and 2's – Or first to 17
4. Jump balls go to the defense
5. Ball must be taken back behind the 3 point line or checked on every possession
6. Fouls: Offensive players call fouls – Ball put back into play behind 3 point line for non-shooting fouls, 1 free throw awarded for shooting fouls with ball going back to the defense
7. One (1) time-out will be allowed per game, per team
8. Flagrant Fouls – 1: Free Throw plus the ball back 2: Team dismissed
