As technology continues to dominate aspects of our daily lives, it is no surprise that we are seeing an increase in the number of online classes offered to students across the country. According to the National Center for Education Statistics, the number of students taking online classes grew by 5.7 percent or 350,000 students from the fall of 2016 to the fall of 2017. Online courses provide flexibility for students to learn anywhere in the country and around the world. They are especially convenient for student-athletes in sports with extended travel times, to prevent them from falling too far behind in their courses. It also helps prevent student-athletes from missing excessive amounts of in-class lectures and assignments.

From the learning specialist perspective, the online class platform also helps provide

an aspect of educational development that is challenging to obtain in the classroom for some students,

especially the student-athlete population that may come in underprepared for the college classroom. For instance, although many online courses have deadlines similar to in-person courses, online classes allow students to review material at their own pace and go back and review material they may have challenges comprehending in a typical 50 to 65 minute class. Working as a learning specialist for six years, I have seen student-athletes face challenges with processing the information presented by the professor in the lecture class and their inability to keep up with fast-paced lecture notes. In an online course, students are able to go back as often as necessary to review information they may be struggling with. In addition, typically, online courses provide students with all the necessary materials and resources needed to be successful in the course including lecture videos, notes, and clear assignment expectations.

Furthermore, applications and software utilized in online classes allows Generation Z students to learn in new and innovative ways that engage them. Recently, we began utilizing the application Flipgrid, which is offered through

the Canvas site at Florida State University, in our Student Leadership and Development course. Flipgrid is a digital discussion board where students can post short videos ranging from one to five minutes long on a designated topic. Students are also able to reply to other students through the application.

Despite the many benefits online classes provide, they are not free from challenges and/ or concerns. We are always concerned with academic integrity and ensuring our studentathletes adhere to those guidelines. Online courses may not provide monitoring for exams/ guizzes which may pose academic integrity concerns. Recently, I have seen an increase in the number of online courses requiring a proctor, whether through the university or online platforms, such as Examity and ProctorU, which can aid in providing academic monitoring. As online courses continue to grow in popularity, we should acknowledge the challenges and concerns that these classes may have, but also realize there are immense benefits and ways to engage the generation of young scholars who have only grown up in a world full of technology.

Imagine compliance and academic services are in a stock car race. If you've never seen a race, here is some information. Each car has an owner and a driver. Now imagine the owners are the universities, and the cars are compliance and academic services.

At some institutions, compliance would be one race team, and academic services would be a different race team. They are in the same race, but working their own plan. However, the actions of one affects the other, because if there is a crash, everyone gets caught up in it.

At some institutions, compliance and academic services would be two cars on the same race

team. They communicate daily. They each have their own race plan. They may let the other draft behind them if

they need a break. They will sometimes help keep another race team from overtaking their teammate. They have each other's back.

At some institutions, compliance and academic services is just one car with one person doing both roles.

If an institution has just one car, they become acutely aware of the members of their pit crew. They need every single one of them to change tires, provide fuel, and make repairs.
