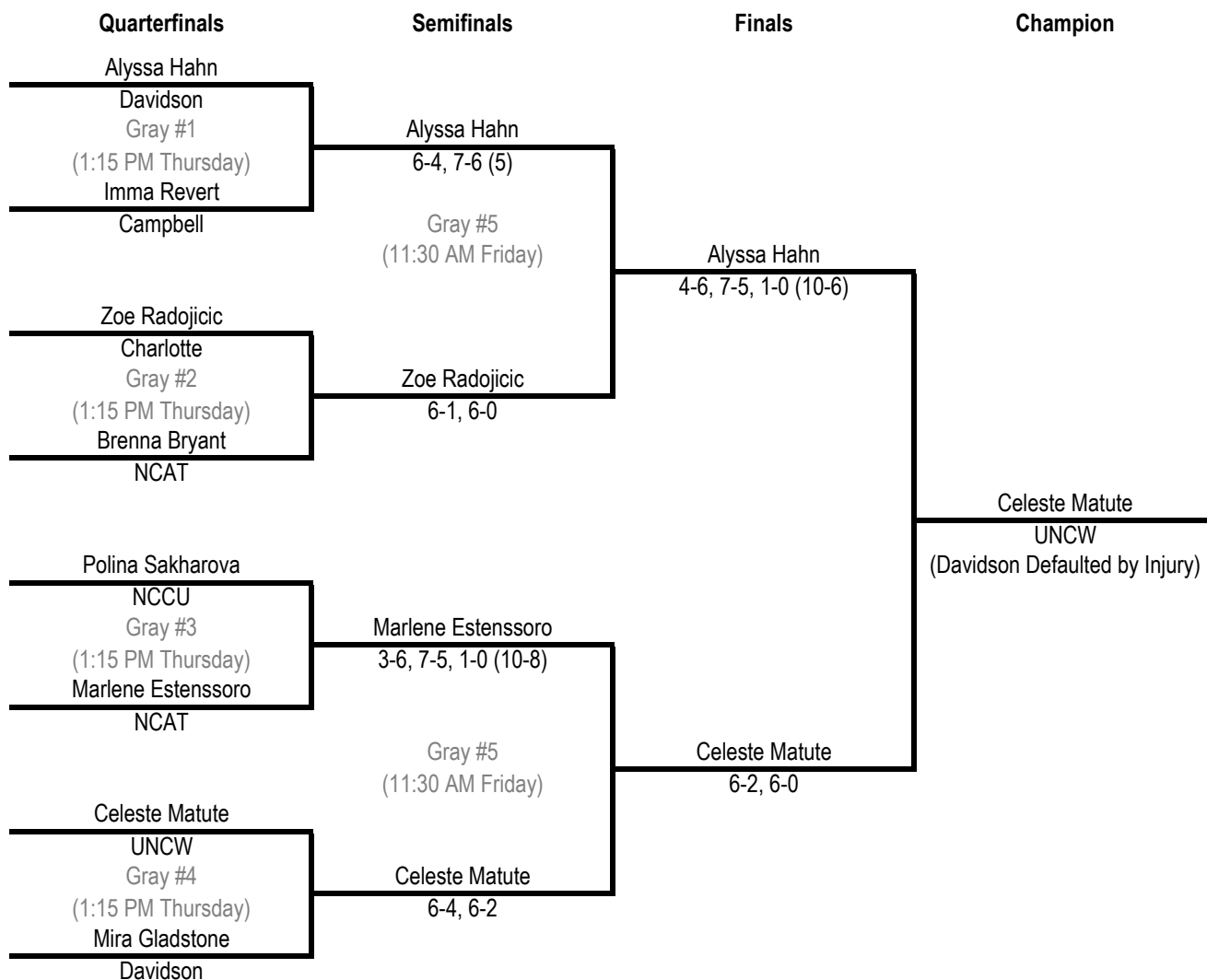

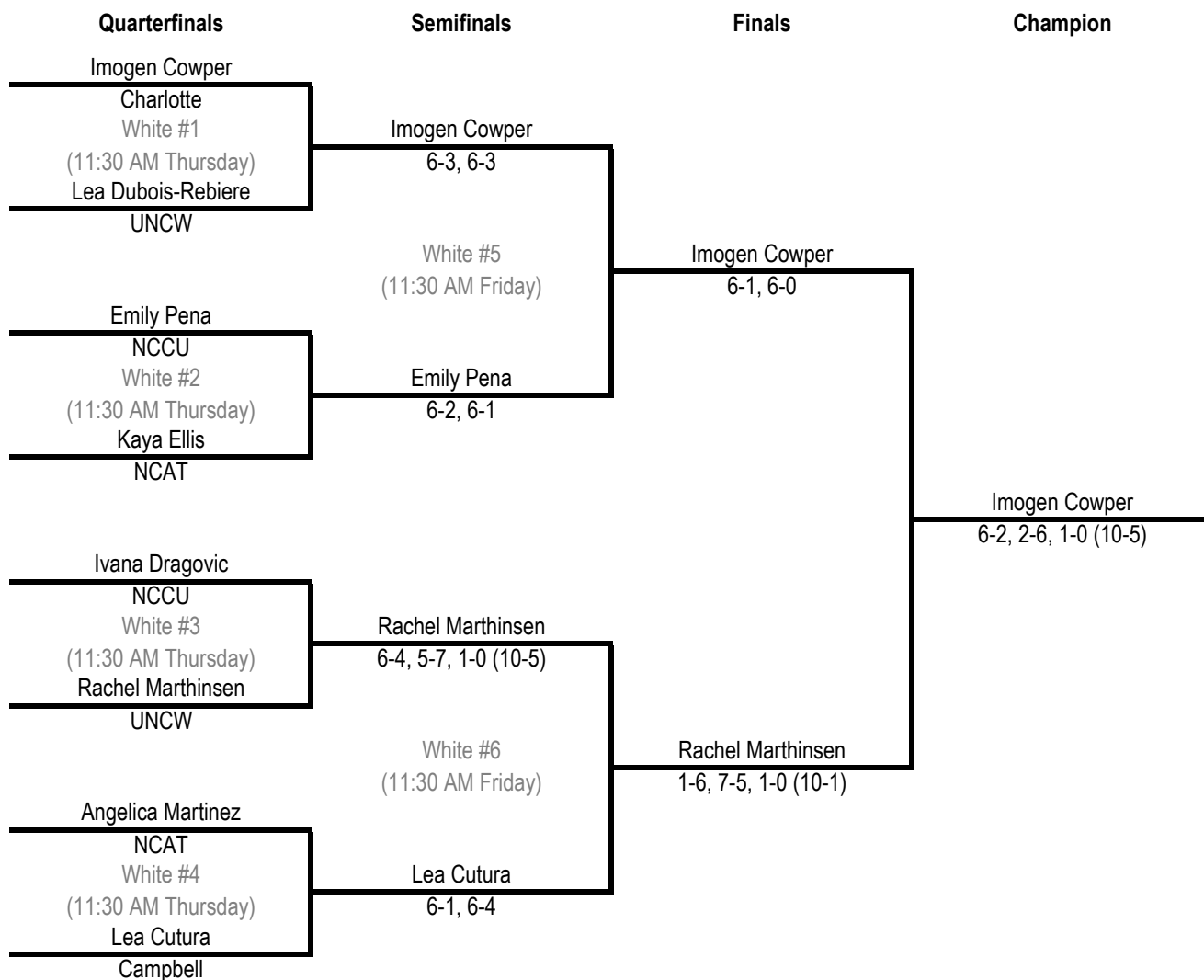
Gray Flight Singles at NCCU Tennis Courts

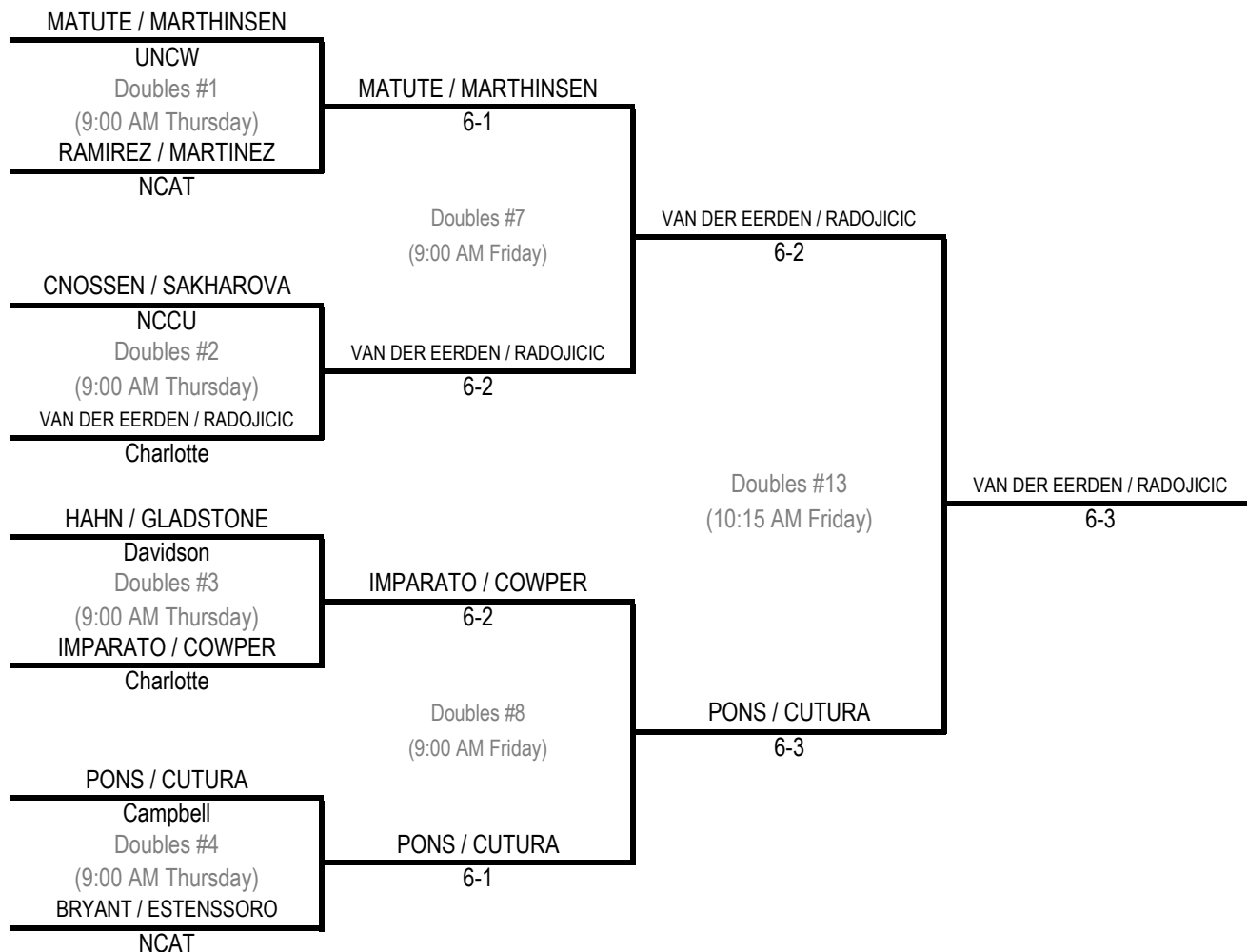

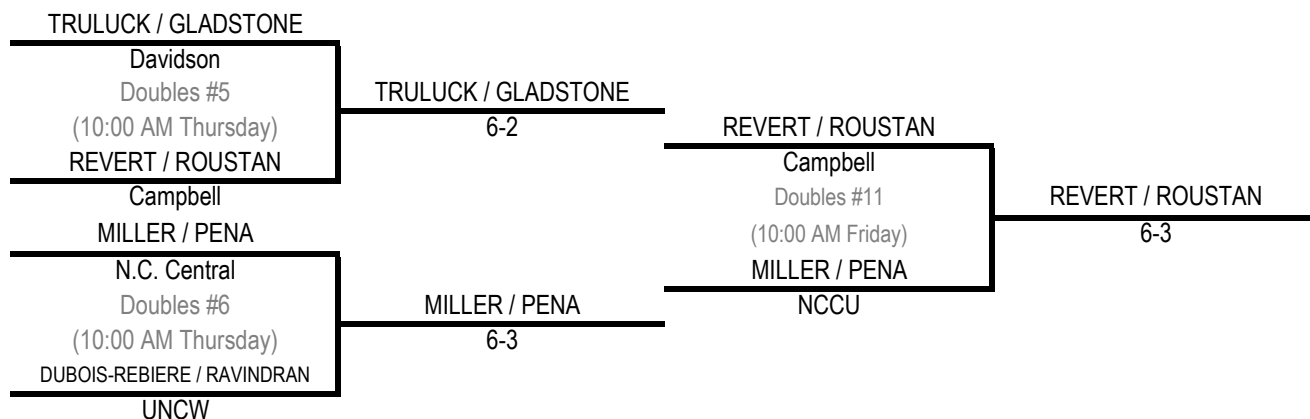
