### District III Foul Weather Policy

Ninety minutes (1 hour and 30 minutes) is the maximum delay of a contest due to weather conditions. When lightning is a factor and instrumentation is available on site, officials shall consult with the Game Manager of the District III contest. Thirty (30) minutes from last lightning strike must elapse before team's retake the field. If the last strike does not allow enough time to resume the game due to maximum delay (90 minutes), and a winner cannot be determined by NFHS or PIAA rule, the game shall be rescheduled or resumed at that point the next available day.

#### All Sports:

- a. Cancellations due to weather require no fee payment unless officials arrive at the game site. Proper notice must be given.
- b. Official arrives at the site and the game is cancelled— Full fee is paid.
- c. Complete suspended game – Full fee is paid.
- d. School forfeits the day of the game, forfeiting school pays officials full fee.
