

UNCG Athletics Hall of Fame Nomination Form

Thank you for participating in the nomination process for the UNCG Athletics Hall of Fame. In order that the Hall of Fame Committee may appropriately evaluate the nominee, please follow these procedures:

1. Submit:
 - a. The completed nomination form;
 - b. A nomination statement of no more than one page, single-spaced, detailing the nominee's qualifications;
 - c. Other supporting materials, including newspaper clippings, letters of recommendation and the nominee's vitae (if available).

All materials will be retained by the committee.

2. Deadline: All materials must be submitted by mail on or before April 1, for consideration into the upcoming Hall of Fame. *A nominee remains in the nomination pool for five years.*

The nominee must meet the following criteria for consideration by the Hall of Fame Committee:

1. In the case of an **athlete**:
 - a. Have been graduated from the institution no less than 10 years prior to nomination, or be deceased;
 - b. If not a graduate, have attended the institution for no less than two years and left in good academic standing no less than 10 years prior to nomination, or be deceased;
 - c. Have been a competitor in one or more sports with extraordinary achievement;
 - d. Have exhibited continuous good citizenship.

Note: Academic achievement and graduation from UNCG is central to the mission of intercollegiate athletics at the University. Occasionally, a student-athlete in good academic standing will postpone pursuit of a degree to take advantage of a professional sport opportunity. The Hall of Fame committee will consider for induction former student-athletes who had a good academic record but have not yet earned a degree from the University. However, it will give priority consideration to those who have earned their degree(s).

2. In the case of a **coach or administrator**:
 - a. Have been employed by the institution for no less than five years and been separated from the institution for no less than five years prior to nomination, be deceased.
 - b. Have made long-lasting, exemplary contributions to the athletics program.
 - c. Have exhibited continuous good citizenship.
3. In the case of **other individuals** (such as supporters):
 - a. Have been closely connected with the athletic program for no less than 10 years prior to nomination;
 - b. Have made long-lasting, exemplary contributions to the athletics program
 - c. Have exhibited continuous good citizenship.
4. Under **special circumstances**, individuals who do not meet the stated criteria may be accepted as nominees. Individuals related to University athletics who have made continued contributions to society through community activities, through their performance in chosen fields of endeavor and through avocations which bring credit and distinction to the University may be considered as nominees. On the rare occasion that such a nominee is approved by the Hall of Fame Committee, the director of athletics and University chancellor will have final approval of that nominee.
