AGENTS REMINDER

Any agreement with an agent, in writing or verbally to market his or her athletic skills will render a student-athlete ineligible for intercollegiate athletic competition. Additionally, any athletics department staff member that introduces an agent to a student-athlete is in violation of NCAA Bylaw 10.1.



SPORTS WAGERING (GAMBLING)

The NCAA prohibits any athletics department staff members, staff members who have responsibilities with or over the athletics department, and student-athletes from wagering anything of tangible value on intercollegiate, amateur or professional athletics competition.

Book Return Reminders

All student-athletes on book scholarship must return all of their books to the bookstore by Friday May 17th. If books are not returned by May 17th, student-athletes will be responsible for the entire cost the book.

Renewals and Nonrenewals

It is our responsibility to notify each student-athlete that is on athletics aid this year by July 1st whether his or her aid will be renewed or nonrenewed. It is permissible for an institution that has notified a student-athlete that they will not be provided athletics aid for the next academic year to subsequently award financial aid to that student-athlete. Please turn in your aid requests for the 2019-20 academic year to Fadia ASAP so that we can ensure the letter's delivery by July 1.

Summer Employment

Please be reminded of the rules regarding employment for student-athletes:

- (a) Compensation may be paid to a student-athlete only for work actually performed;
- (b) All earnings must be the "going rate" for the type of work performed;
- (c) Compensation may not be awarded based on the publicity, reputation, fame or personal following obtained because of a student-athlete's athletics ability; and
- (d) An employer shall not use the athletics reputation of a student-athlete employee to promote the sale of the employer's product or services.

* The Student-Athlete Employment Form must be submitted to the Compliance Office.

Final exam and Summer CARA

Sports In Declared Playing Season

- CARA is still limited to 20 hours/week during final examinations.
- CARA is not limited to 20 hours/week starting May 18th.

Sports Outside of Declared Playing Season

CARA may not be conducted starting the week prior to final examinations (May 6) through the end of UTEP's final exam period.

- Starting May 14th, all workouts must be voluntary in nature. Strength and conditioning coaches that are not countable coaches can conduct these workouts at the request of a student-athlete.

**In Rifle, and Track & Field events such as hurdles/ steeplechase and field events; a coach may be present at the workout for safety reasons. The coach may NOT conduct the workout.

Athletics Apparel

A student-athlete may retain athletics apparel items (not equipment) at the end of the individual's collegiate participation. Used equipment may be purchased by the student-athlete on the same cost basis as by any other individual interested in purchasing such equipment.

Unofficial Visits: Reminders

An unofficial visit is when a prospect makes a visit to UTEP's campus at their own expense. There are no limits on the number of unofficial visits a prospect may take. A prospect may eat with coaches, other prospects, or student-athletes on UTEP's campus during an unofficial visit as long as they pay for their own meal. UTEP coaches may only provide transportation on campus, to view practice or competition sites.
