AGENTS REMINDER

Any agreement with an agent, in writing or verbally to market his or her athletic skills will render a student-athlete ineligible for intercollegiate athletic competition. Additionally, any athletics department staff member that introduces an agent to a student-athlete is in violation of NCAA Bylaw 10.1.



SPORTSWAGERING (GAMBLING)

The NCAA prohibits any athletics department staff members, staff members who have responsibilities with or over the athletics department, and student-athletes from wagering anything of tangible value on intercollegiate, amateur or professional athletics competition.

March Madness

Entering a March Madness bracket pool for 5\$? No big deal, right? Wrong! This is actually an example of sports wagering under NCAA rules. Coaches, staff and student-athletes may not participate in NCAA March Madness bracket pools that have an entry fee or require something of value up front to win any prize.

Spring Break Practice Reminder

Spring Break is March 16-20, 2020. For sports in their 8-hour out-of-season segment, no CARA is allowed during spring break. However, for sports that are in their declared 20 hour playing season, daily and weekly hour limitations do not apply to CARA occurring during spring break. Student-athletes must still be provided with their one day off per week during spring break.

Recruiting Publicity

Before commitment, an institution:

- May NOT comment generally about a PSA's athletic ability.
- May NOT publicize a PSA's visit to campus.
- May only confirm recruitment.

Prior to commitment, institutions may not comment (e.g., orally, via text, photograph, image or graphic), directly or indirectly referencing a specific PSA's commitment. Direct or indirect references to PSAs include (but are not limited to):

- Name, nickname or variation of PSA's name (e.g., "sounds like");
- Location (e.g., home town, states, area code, or address); or
- Jersey number.

Electronic Correspondence Quick Guide Chart

ACTION	PRIOR TO COMMIT	AFTER COMMITMENT
FRIEND/FOLLOW A PSA	PERMISSIBLE BEFORE FIRST DATE TO PROVIDE RECRUITING MATERIALS IF AUTOMATICALLY-GENERATED NOTIFICATION IS NOT MODIFIED AND NO ADDITIONAL COMMUNICATION.	PERMISSIBLE
ENDORSE (E.G., LIKING OR FAVORITING) PSA'S POST	PERMISSIBLE. ACTION THAT INDICATES APPROVAL.	
ASSOCIATE (E.G., TAGGING OR MENTIONING) PSA PROFILE	NOT PERMISSIBLE ELECTRONIC CORRESPONDENCE BECAUSE THE COMMENT IS NOT PRIVATE.	
COMMENT ON PSA'S POST	NOT PERMISSIBLE ELECTRONIC CORRESPONDENCE BECAUSE THE COMMENT NOT PRIVATE. NOT PERMISSIBLE FORM OF PUBLICITY. MORE THAN CONFIRMATION OF RECRUITMENT.	
RESPOST PSA'S POST WITH COMMENT	NOT PERMISSIBLE ELECTRONIC CORRESPONDENCE BECAUSE THE COMMENT IS NOT PRIVATE.
