## AGENTS REMINDER

Any agreement with an agent, in writing or verbally to market his or her athletic skills will render a student-athlete ineligible for intercollegiate athletic competition. Additionally, any athletics department staff member that introduces an agent to a student-athlete is in violation of NCAA Bylaw 10.1.



## SPORTS WAGERING (GAMBLING)

The NCAA prohibits any athletics department staff members, staff members who have responsibilities with or over the athletics department, and student-athletes from wagering anything of tangible value on intercollegiate, amateur or professional athletics competition.

## March Madness

Entering a March Madness bracket pool for 5\$? No big deal, right? Wrong! This is actually an example of sports wagering under NCAA rules. Coaches, staff and student-athletes may not participate in NCAA March Madness bracket pools that have an entry fee or require something of value up front to win any prize.

## Spring Break Practice Reminder

Spring Break is March 15-19, 2021. For sports in their 8-hour out-of-season segment, no CARA is allowed during spring break. However, for sports that are in their declared 20 hour playing season, daily and weekly hour limitations do not apply to CARA occurring during spring break. Student-athletes must still be provided with their one day off per week during spring break.

## Financial Aid Agreements

### Reduction or Cancellation Permitted

Institutional financial aid based in any degree on athletics ability may be reduced or canceled during the period of the award if the recipient:

- (a) Renders himself or herself ineligible for intercollegiate competition;
  - (b) Fraudulently misrepresents any information on an application, letter of intent or financial aid agreement (see Bylaw 15.3.4.2.3);
  - (c) Engages in serious misconduct warranting substantial disciplinary penalty (see Bylaw 15.3.4.2.4);
  - (d) Provides the Athletics Compliance Office with written Notification of Transfer (see Bylaw 13.1.1.3); however, financial aid may not be reduced or canceled until the end of the regular academic term in which notification of transfer is received;
  - (e) Violate any document institutional rules or policies (e.g., team rules, Athletics Department or Academic policy); or
  - (f) Voluntarily (on his or her own initiative) withdraws from a sport at any time for personal reasons; however, the recipient's financial aid may not be awarded to another student-athlete in the academic term in which the aid was reduced or canceled.
- Entering the transfer portal does not constitute a voluntary withdrawal.

### Reduction or Cancellation Not Permitted

Institutional financial aid based in any degree on athletics ability may not be reduced or canceled during the period of its award:

- (a) On the basis of a student-athlete's athletics ability, performance or contribution to a team's success;
- (b) Because of an injury, illness, or physical or mental medical condition (except as permitted pursuant to Bylaw 15.3.4.2); or
- (c) For any other athletics reason.

## Wearable Technology - When is it CARA?

Use of wearable technology must be either:

- Counted within CARA hours (maximum of 20 hours in-season/8 hours out of season); or
- Voluntary athletically related activities (Bylaw 17.02.19).
  - o Not required to be reported back to a coach or other athletics department staff member by a student-athlete; or
  - o Not reported back (recorded) to the coach through the use of the device;
  - o Initiated by student-athlete; and
  - o No penalties for non-participation.

What is wearable technology?

- Examples include: digital watches (e.g., Apple Watch, Fitbit) or any other wearable device which transmits or records physical workout data (e.g., heart rate, steps taken)

Coaches may not access data generated from wearable technology used by student-athletes during voluntary activities or summer activities. If strength/conditioning coaches or athletic trainers view data generated from wearable technology, they must keep all data private between student-athletes and the staff member. Data may only be shared with coaches if activity was part of CARA or there is a specific health and safety issue that is identified during the workout. Student-athletes are allowed to personally share any generated data on facebook, twitter or any other online forum for their followers, provided this is not done at the direction of the coaching staff.
