For each dual meet, the Referee shall designate, in advance, THE official scoresheet for the meet and shall verify it periodically. No changes may be made on the official scoresheet, except by the expressed instruction of the Referee, such as in the case of a proven error in recording a score or result. Errors, if any, must be brought to the Referee's attention immediately upon discovery.
