REFUNDS

Full refunds are available to participants who are not happy with the program within 15 days of purchase. In order to qualify for a refund you must have purchased The Redefined Process within the 15 days prior to making your refund request. You also must have completed the first two sessions of The Redefined Process and have participated in the program Facebook group by creating a post to share your art and writing from each session, and attended or viewed at least one coaching call. If you still are not happy with the program after completing these first two sessions and participating in the Facebook group, then you may request a full refund by emailing support@jenniferakramer.com.

ONGOING ACCESS

After purchasing The Redefined Process, participants maintain full access to the program content via the online program content site. This includes any updates of add-ons made to the program over time. Participants also maintain access to The Redefined Process Facebook group and all ongoing group coaching calls that occur within the group.

DECLINED PAYMENTS

If your automated payment is declined for any reason, you will receive a series of email and/or phone notifications to inform you of the error. You will have three days to correct the error before access to all program content and Facebook group will be interrupted. Loss of access to the program will continue until payment is made. Failure to make payment will result in permanent termination of access to The Redefined Process online program content and access to the program Facebook group.
