**Scope and Content:** The collection includes financial records, meeting minutes, guest registers, committee reports, membership lists, and other documents about Le Petit Salon in New Orleans.

**Historical Note:** Le Petit Salon was organized on December 31, 1924, by a small group of women who had as their objectives to keep alive the love of the old traditions of New Orleans and wherever possible to keep and preserve old historic buildings and to promote enjoyment, harmony, refinement of manners, and intellectual improvements and to revive, promote and continue the pleasant intercourse of the Salon. The Salon has its home in the mansion built in 1838 by Victor David on St. Peter street. Miss Grace King served as its first president and later Dorothy Dix (Mrs. E. M. Gilmer) served the organization in that post for many years.
