

# **“Touring For Startups” Sample Contract #1**

*This contract was used to secure a venue and event planner for Corset Magazine’s Sensuality, Sexuality, & The Erotic Tour. Company names, dates, and contact information have been changed.*

This contract is entered into this day of April 7, 2013 between XXX Miami Lounge (VENUE), Professional Planning Events (PPE), an event consulting company and Corset Magazine (CLIENT), specifically for the event called “Sensuality, Sexuality and the Erotic – Eat, Sip, Listen: A 20 – City Global Tour.

PPE agrees to provide event planning coordination services for her CLIENT. To ensure a first class event, PPE will perform the services outlined below on a nonexclusive basis, under the direction, guidance and assistance of the VENUE, to the best of its professional abilities.

## **DEFINITION & TERMS:**

1. Definitions: XXX Miami Lounge located at 5 Ocean Drive, Miami Beach, FL 33139, shall be henceforth referred to as “VENUE”. PPE, through the services of Amelie Rochester, its employee, shall be henceforth referred to as “EVENT PLANNER”. “EVENT BOOKING” is defined as the actual event scheduled for this contract.
2. This contract is specifically for Friday, June 7, 2013 from 6:00 p.m. – 10 pm. It shall be henceforth referred to as “EVENT”.
3. Duration of Contract: VENUE, EVENT PLANNER and CLIENT agree that duration of this contract is for the actual event date, June 7, 2013.

## **EVENT DETAILS:**

1. Date: Friday, June 7, 2013
2. Time: 6:00 p.m. – 10 p.m.
3. Menu: Prefix created by VENUE
4. Sound: Microphone Needed. Sound system needed for background music. No DJ Needed unless Venue already paid for this expense.
5. Estimated Guest Count: 100 people
6. Free Admission for All Guests
7. Sponsor: Erotic Liquor will sponsor 100 free cocktails for the event (1 free Erotic cocktail per first 100 guests to be provided upon entry)

**COMPENSATION:** VENUE and EVENT PLANNER agree to following distribution of Revenue from the EVENT:

- a. CLIENT will relinquish all liquor and food sales to the VENUE.

- b. EVENT PLANNER to receive a flat fee of 10% of all food and liquor sales from the VENUE

**PAYMENT SCHEDULE:**

In consideration for the services of PPE & VENUE hereby agrees to pay to EVENT PLANNER immediately following the EVENT.

**GOVERNANCE:**

This Agreement shall be governed by the laws of the State of Florida, and the exclusive venue for any dispute arising under this Agreement shall be the courts in Broward County, State of Florida. This Agreement represents the entire agreement between the parties, supersedes any prior understandings or agreements, written or verbal, between the parties, and may not be amended except by a written instrument signed by both parties hereto.

**INDEMNITY:**

PPE shall not be liable for any claims, demands, actions, suits, obligations, losses, damages, liabilities, expenses or costs (including reasonable attorney's fees), including but not limited to personal or bodily harm or property/equipment damages, arising out of or relating to the event, the Services provided hereunder, delays in delivery or service by vendors, or for damages done to or caused by any vendor or third-party, and Client shall indemnify, defend and hold PPE harmless from the same. In any event, PPE's maximum liability under this Agreement shall be limited to the amount paid by Client hereunder.

**DISSOLUTION:**

This contract, or any of aforementioned items listed, can at any time be served if and only if both EVENT PLANNER and VENUE are in mutual agreement to such changes in the duration of the life of the NIGHT or specie of the contract. Agreed to on this 7th day of April 2013.
